Twenty-Five (25) of the Sparring Rounds Shall be Completed at a Separate Approved Referee Training Facility than their Primary Training Gym. The Trainee Must Also Pass the ABC Referees' Course Prior to Completion of their Training. All Rounds Must be Signed-Off on by the Approved Gym's Head Trainer. All Referee Trainee's are to Notify the AAC When They are Within Ten (10) Rounds of completing their training. Only the Chief Inspector of the AAC Shall Provide Certification of a Trainee's Readiness to perform Refereeing Duties.
